DATA CENTER ENERGY USE

Half of the energy consumed by a data center is used to cool the equipment. Typically, customers who engage in incentive programs for data centers have found ways to reduce their energy consumption significantly. IPL's Custom Incentive Program helps to offset the financial investment for these types of projects.

Financial incentives

- Incentives are capped at 50% of the total project cost, up to \$100,000 per project.

1. General information
 - Facility type, operating hours and square feet
 - 12 months of electric utility data
 2. Summary of current equipment
 3. Summary of measures you plan to implement
 4. Supporting energy savings calculation for each measure
 5. Detailed proposed project costs

EXPLORE

Identify which energy-efficient upgrades are available to reduce energy consumption.

PRE-APPROVAL APPLICATION

Complete and submit the Custom Pre-Approval Application and submit along with supporting documentation.

RECEIVE LETTER OF INTENT

You will receive a Letter of Intent (LOI) both authorizing you to move forward and informing you of the incentive amount reserved for your project.

SUBMIT AND COMPLETE PROJECT

Sign and return the LOI. You then have 90 days to complete the project.

A one-time extension may be granted.

SUBMIT FINAL APPLICATION

Once the project is complete, submit the Custom Final Application with supporting documentation.
