What are the enrollment options?	Customers select a percentage of their monthly electric usage to be enrolled in the program: 25%, 50% or 100% (business customers can also select 10%).						
How much will the Green Power Option cost?	The current additional charge (or “premium”) is \$0.002500/kilowatt-hour enrolled.						
How will I be billed?	The premium for participating in the Green Power Option will appear as a line item on your regular monthly IPL billing statement.						
How will my bill be calculated?	The premium is calculated by taking <i>(the % you selected at enrollment) x (your monthly kilowatt-hour usage) x (the Green Power premium)</i> . This additional charge will be added to your regular IPL rates and charges and applicable taxes will apply.						
How much will my total electricity service cost, including utility charges?	Based on a typical monthly usage of 1000 kWh , the following example provides an estimate of your monthly electricity bill <i>(as of September 2018)</i> , if you participate in the Green Power Option from IPL. Will the Green Power Option premium change over time?	The premium for the Green Power Option will adjust once per year through a filing with the IURC and will be based on IPL’s cost to purchase renewable energy credits plus reasonable costs to administer the program. You will be notified of the premium change via a message on the bill statement the month it becomes effective.						
What sources will be used in the Green Power Option?	IPL procures Renewable Energy Certificates (RECs) for this program. More information regarding RECs, along with a Product Content Label, can be found at www.IPLpower.com/GreenPower/ .						
How do I terminate this agreement?	You can end your participation in the Green Power Option at any time either by contacting IPL Customer Service or via our website at IPLpower.com . Your termination will be effective immediately.						
What length of agreement/contract is required?	There is no contract required, and participation is month-to-month. There is no fee for terminating your participation.						
What other fees might I be charged?	None.
