Custom Incentives Program Pre-Approval Application

Thank you for participating in Indianapolis Power & Light Company's (IPL) Business Energy Incentive Program. Refer to the information below to ensure you are eligible for program rebates and your application is complete.

What you will need:

1. Your IPL account number, IPL Service ID and Rate Code
2. Twelve months of energy bills
3. Electric savings calculations
4. Project proposal/ scope of work/ proposed equipment specification sheets
5. Installing contractor information (if available)
6. Payee's IRS form W-9

How To Apply For A Rebate

Step 1: Determine Eligibility

Applicant:

The applicant must be an active IPL business customer with a qualifying Rate Code at the time of equipment installation.

Application and Installation:

The application must be completed in full and signed prior to submittal.

Equipment and Installation:

In order to qualify for an incentive you may not purchase or install equipment until receiving pre-approval from IPL in the form of a Letter of Intent.

Step 2: Complete Application & Attach Supplemental Documentation

Complete Pre-Approval Application:

Unless noted otherwise, all fields must be completed on the application.

Sign Application:

The application must be signed in the space provided on page 4.

Attach Supplemental Documentation:

Ensure that you have attached a copy of all documentation to the rebate form.

Documentation should include:

- Twelve months of electric bills (a monthly summary is acceptable)
- A detailed scope of work
- Itemized costs for the proposed scope of work
- Savings calculations
- Facility description and run hours

Program applications and required documents may be submitted using any of the three methods below:

Submit Application:

Submit pages 3 and 4 of your completed application and supplemental documentation through one of the methods posted above.

Terms and Conditions

General Eligibility

This offer provides financial incentives for the purchase of new, installed qualifying equipment and is not dependent on the purchase of any other equipment unless indicated. Offer valid only for IPL customers served under non-residential rate SS, SE, SH, SL, PL, PH or HL. Equipment must have IPL electric service. Incentive funds are limited and available on a first-come, first-served basis.

Verification

IPL reserves the right to verify sales receipts and/or installations of equipment and that the equipment installed meets program requirements before granting incentives. A random inspection may be conducted to verify installations.

Program Modifications

IPL reserves the right to alter or discontinue this incentive offer at any time without notice. Financial incentives are limited and are available on a first-come, first-served basis.

Rebate Calculations

Incentive amount is calculated based on first year energy savings. The incentives are earned at \$0.07 per kWh or \$0.08 per kWh saved, depending on project type. Incentives are limited to a maximum cap of \$100,000 per project at a service ID and/or building behind a master meter. Projects may be broken down by technology type, but will require a separate application for each technology. Total combined Custom and Prescriptive incentives are capped at \$500,000 per customer per calendar year. In no case will the program pay more than 50 percent of the total material and external labor cost.

Eligibility Dates

This incentive form is only eligible for qualified purchases and installations performed on or after January 1, 2020.

- Before starting an energy efficiency project, the IPL customer must complete and submit this application as directed on Page 1 for approval. The IPL Business Energy Incentive Program incentive cannot be granted without prior completion of this application, and subsequent approval by IPL. Energy service companies or contractors may assist in preparing the application, but an authorized representative of the IPL customer must sign this application to be eligible to participate in the IPL Business Energy Incentive Program. Completion of this application does not guarantee the approval of a Custom Incentive.

- **Do not begin your energy efficiency project(s) or purchase equipment until you receive written approval in the form of a Letter of Intent from IPL. The project should be completed within 90 days of acceptance unless written approval for project extension is received from IPL and its Business Energy Incentive Program representatives.**
- Eligibility for Custom incentives on LED lighting is limited to products that appear on one of the following qualified product lists (QPLs):
 - ENERGY STAR® qualified LED light bulbs.
 - ENERGY STAR qualified commercial LED lighting.
 - DesignLights™ Consortium QPL.
 - If your products are not included on the ENERGY STAR or DesignLights Consortium QPLs, please contact the program manager at 317.829.2760.

Product use must be in alignment with category that product is listed under.

- Once all documentation is received by IPL (a site inspection may be completed if necessary), IPL will complete an engineering review and indicate the anticipated Custom Incentive amount in a letter of intent based on the projected energy savings. Upon completion of the project and verification of installation and operation of the energy saving measures, IPL will issue a Custom Incentive check in the amount indicated in the letter of intent, or adjust if the project varies from the information originally submitted.
- Measures must meet minimum cost-effective requirements as determined by IPL. Installed energy efficiency measures must have at least a five-year measure life and a one-year minimum payback period prior to incentives.

Taxes

Incentives are taxable and if greater than \$600 will be reported to the IRS unless you are exempt. The third-party administrator will report the rebate as income to you on IRS Form 1099 unless you have checked corporation or exempt status on page 1. You are urged to consult your tax advisor concerning the taxability of incentives. IPL is not responsible for any taxes that may be imposed on your business as a result of your receipt of this incentive.

Environmental Attributes

Customer agrees to transfer to IPL all "Environmental Attributes" attributable to the Energy Efficiency Projects or its operation. Environmental Attributes include any and all credits, benefits, emissions reductions, offsets and allowances, howsoever entitled, resulting from the avoidance of the emission of any substance into the air, soil or water at or by IPL generating facilities through reduced generation of energy or other savings or offsets on account of the Energy Efficiency Project(s). Customer will not claim ownership of any Environmental Attributes. As long as Customer at the same time states the Energy Efficiency Project(s) was made possible with funding from IPL, Customer may claim that it is facilitating the production of the Environmental Attributes attributable to the Energy Efficiency Project(s).
